EXP101: CANADIAN EXPORT CONTROL PRIMER

This short course introduces the concept of Export Controls for individuals who work in an environment impacted by export controls, who may not have direct responsibilities related to exports, but need to be made aware of their responsibility in avoiding any action that may breach export control laws.

This won't be an exhaustive presentation of all possible product environmental requirements. However, the main categories and requirements, especially in the electronics industry, will be presented.
